Free Style

Anything goes. Custom frame, one off drive train, anything.

Custom Big Twin Softail

Based off an OEM or aftermarket Harley style softail frame. May be raked or stretched.

Custom Big Twin Rubbermount

Based off an OEM or aftermarket Harley Dyna/FXR style swingarm frame. May be raked or stretched.

Custom Bagger

Based off an OEM or aftermarket FL rubbermount touring frame. May be raked or stretched

Custom Sportster

Based off an OEM or aftermarket Sportster swingarm frame. Hardtail sections are allowed. May be raked or stretched

Custom Retro

All pre-1984 models. Modified or aftermarket frames of any configuration are allowed. Engine must have original cases; replica engines are <u>not</u> allowed.

Antique

All pre-1966 models with an original frame and drivetrain.

Custom 3 Wheel

Must have 3 wheels in a trike or sidecar configuration

Custom Metric

Based off a metric cruiser or touring bike. May be raked or stretched. Hardtails sections are allowed.

Custom Sportbike

Must be based off an original sportbike platform. Frame may be raked or stretched. Extended swingarms and wide tire kits are allowed.
